#### MINUTES OF THE MEETING


### Delhi Branch of Indian Speech and Hearing Association

Date -12-01-2020 Sunday Timing – 9:30-1:00pm

- 1. The first Meeting of DISHA was organized at *Constitution Club of India* and was attended by **46 ASLPs**
- 2. The meeting was initiated by welcoming of the gathering.
- 3. The meeting was hosted by **Ms. Stuti Sharma**.
- 4. Because of the absence of the President DISHA, Ms. Asha Agarwal, **Neevita Narayan** was invited to be the chairperson for the session.
- 5. The meeting began with the presentation of *By-laws* by **Ms. Priyanjali Harit**.
- 6. Following changes/amendments were suggested by the professionals-
- a) Under the section Aims and Objectives 'Form' the rehab centers should be omitted.
- b) Honorary, Student, Associate membership should be added
- c) Honorary Members- don't have to pay for the membership
- d) Student Members can pay 500 annually
- e) Associate Members can also be included
- f) It was decided that the life members can only vote during the Elections.
- g) **Mr. Himanshu Khanna** added that the honorary members can't claim any funds from the association and it was concluded that the honorary members should be from the allied health field and should not pay for the membership.
- h) During the discussion of the Executive Body **Ms. Meenakshi Wadhera** suggested if we can have a post –Joint Treasurer; Sub committees for the association.
- i) Ms. Meenakshi added that the AGM should be decided in the previous meeting but in case of emergency can be decided 2 months prior.
- j) **Mr. Vijay** suggested that voting during AGM can be changed to ballot system rather than showing hands.
- k) A few changes like Principal should be changed to General, Chairman should be changed to President as suggested by **Mr. V.P. Shah.**
- I) During the discussion about the Dissolution of the association; The query was raised by Mr. Himanshu –whether or not its Irrevocable?
- m) The By- Laws presentation ended with a plenty of inputs and queries.

- 7. The meeting was continued with the presentation by Mr. Prabhash on Account Details.

- 11. **Mr. Subodh** stated that there are non-professions also in the WhatsApp group. For which Ms. Priyanjali told that once we have sufficient amount of life members, we will create separate official life member WhatsApp group.
- 12. Ms. Meenakshi explained the process of voting someone needs to nominate and the person should also be second by someone
- 13. Mr. V.P. Shah sir stated that nominated person should be BASLP
- 14. Mr. Jitendra discussed the following concerns
- A. Why another DISHA Facebook page is still functional?
  - Ms. Meenakshi told that it was created long back
- B. During Noise Awareness activity it has been observed that there was *Violation of code of conduct* had happened and Mr. Jitendra asked that what step should be taken in such situation?
- Ms. Meenakshi said that it is bad to take the matter again and apologized.
- **Ms. Vani** asked since this has happened, what actions should be taken if someone else repeats the same in future?
- Mr. Himanshu suggested that Ethics Committee will be Incharge of such matters.
- Mr. V.P. Shah said, it is first time mistake so it can be ignored for now.
- **Mr. Jitendra Saini** asked if someone does the same in future and if we take action against that person then he/she might ask why special privilege was given earlier to the defaulter?
- Ms. Meenakshi Wadhera said that there is no Ethics Committee so far.
- **Mr. Jitendra Saini** asked considering this if someone does the same before formation of ethics committee than would that person be pardoned in the similar manner??

Ms. Neevita stated that President- **Ms. Asha Agarwal** refused to be the signing authority for bank documents and asked **Ms. Neevita Narayan-**Vice President to take the responsibility. All EC Members agreed to it.

The collective decision was made that ASLPs who finished the DISHA registration before 12th March 2020 will be *only* eligible to vote in the next GBM.

Ms. Meenakshi suggested that the registration message should be circulated every day in the WhatsApp group.

It was also decided that the Existing EC will also appear for nomination

Nomination should be seconded by 1 life member and proposal of Nominee sign can be send in pdf form to the registered address as well as official mail.
